November 7, 2013
Minutes**

Call to Order: 6:34 p.m. by Vice-Chair Chapin.

Minutes

The minutes of October 3, 2013 were unanimously approved with corrections by a motion by Marjie and a second by Kathy.

Meeting with LOSAC representative Josh Abram

Josh discussed the LOSAC goal to reach out to all of the Advisory Committee's. LOSAC host Open Space Day and Arbor Day that are good contenders to recycling and/or Zero Waste activities. There is sometime food catered in to feed the volunteers along with bottled water, for example. LOSAC is looking for assistance on "How to" or best practices to run their events as recycling or ZW. They would also be willing to hand out WRAC information at LOSAC events. The group discussed how WRAC could help LOSAC on their events and a brief primer on what must be done to hold a ZW event. Josh will relay this information to LOSAC and see if this could be done for 2014. Doug will work with Monte Stevenson, LOSAC staff liaison, about coordinating these activities and keep each Advisory Committee informed.

2014 Budget Request

The group discussed Julie's research on table skirts and with a first by Marjie and a second by Kristi and with unanimous approval, proposed a design, color, wording and style. Doug's staff will work on a mock up and solicit comments from the group before ordering.

Board Member Application

The group discussed Anna Fargo's application and with a motion by Kathy and a second by Marjie the group unanimously approved her application to the WRAC Board and recommended approval by City Council.

Old/New Business

- Marjie discussed the effort needed by WRAC to support next year's proposal for a three cart, PAYT throw system for the entire City. Marjie indicated it would be timely for WRAC to hold a December meeting to continue this discussion. With a motion by Kristi and a second by Marjie and a vote of 3 to 1, Jeff abstaining, the motion was approved. Jeff asked that the power point presentation to Council last year be forwarded to him that showed the discussion of WRAC supporting a 3-cart PAYT city wide system. Doug will see if Randy Morman from Eco-Cycle can attend.

Meeting adjourned at 8:03 p.m. with a motion by Kathy and a 2nd by Marjie with unanimous approval.
